Prerequisites:

- Successful completion of Psychiatry Clerkship rotation.

A Selective is a course that will be taken at the end of the Clerkship Phase or during the Post-Clerkship Phase of the curriculum. It will take the place of the currently required “Sub I’s” and “Critical Care Blocks”. The Selectives should be rigorous and will be graded Honors/High Pass/Pass/Fail. The course description should reflect that rigor and include an overview of content, environment, student responsibilities, and expectations.

I. Course Description

This Psychiatry selective will take place on the Parkland Consultation-Liaison service. The student assigned to this selective will be expected to function at the level of an intern, under the direct supervision of attending faculty members, psychosomatic psychiatry fellows, and psychiatry residents. The student will be assigned patients and be responsible for their management for the time-period that the psychiatric consult service is involved in their care. The student will assess patients, develop and implement patient care plans. They will be specifically graded on their ability to manage patients. The student will be expected to participate in rounds, attend weekly educational activities and contribute to the education of other medical students and psychology trainees. The student is required to demonstrate critical thinking and medical knowledge via a formal assessment method which will include a formal presentation on an approved topic with evidence of literature review. The student will be required to demonstrate competence in working within a large health-care system and with the CL-service’s interdisciplinary team structure.

IV. Overview of student responsibilities:

The student will be assigned to provide psychiatric consultation to patients on the consult liaison service at Parkland Hospital under the direct supervision of attendings, fellows, and residents on the service. The student will perform psychiatric evaluations including mental status examinations and development treatment recommendations that will be communicated to the primary team. The student will present the findings from their evaluations to attendings on the consult service and document findings in the medical record. The student will attend team rounds and work with all members on the consult liaison service, including psychologists, and social workers.

V. Method of evaluation of students and requirements: Direct observation of psychiatric interview, formal presentations, documentation of consults and progress notes, communication with team members and consulting staff. Students will research a topic approved by the attending perform a literature search and do a formal 30-minute presentation on the topic. Any format can be used for the presentation (oral, PowerPoint, Prezi, handouts, etc). Students will be graded Honors/High Pass/Pass/Fail.
